## ELIGIBILITY:

- Entries submitted only by the artist & limited to four entries.
- Only artists residing in the Interior of Alaska, Doyon Region.
- Original artwork only. Work must reflect the artist's unique creative effort.
- No kits. No copies or exact replicas of other original artwork or published artwork (***No copies of any published images or copyrighted characters, i.e. Disney.***)
- Work must have been completed **within the last two years** and NOT PREVIOUSLY EXHIBITED IN THE BEAR GALLERY.

## CONDITIONS:

- Selected entries must remain on display through 6pm on Saturday, April 28, 2018.
- Entries will be handled with the greatest possible care and are insured against damage or loss for the duration of the exhibit. FAA is not responsible for minor wear resulting from normal handling.
- FAA retains a 35% commission on all exhibit sales. Works will be for sale unless noted as NFS (Not for Sale). Artist's payments will be made within 30 days after an exhibit's closure.
- Submitting an entry constitutes agreement on the part of the artist to all conditions in this prospectus.

## INSTRUCTIONS:

- Entries must be ready for display, matted and framed.
- Works to be hung on the wall must have wire hangers. NO SAWTOOTH hangers.
- Unusual hanging mechanisms must be approved by the Program Coordinator.
- Large Quilts must have 2 inches of Velcro stitched along the entire top. NO VELCRO, NOACCEPTANCE.
